Forkhill is a small historic village located in South Down within the picturesque Ring of Gullion. The village is approximately 9 miles south west of Newry City centre, approximately 48 miles south of Belfast and approximately 59 miles north of Dublin. The village is close to the border with the Republic of Ireland with surrounding villages including Meigh, Silverbridge and Crossmaglen. The hinterland to the village is mostly agricultural in nature.

Description

46 Church Road is a traditional single-story bungalow. The property consists of 3 bedrooms, 2 reception rooms, a kitchen and a family bathroom. The property is accessed from a single lane concrete driveway and has fields to the front a rear. The bungalow is subject to a lifetime tenancy.

Planning was approved for 46 metres north-west of 46 Church Road on 2nd March 2007, for an erection of replacement dwelling ref: P/2007/0348/RM. Foundations have been put in place.

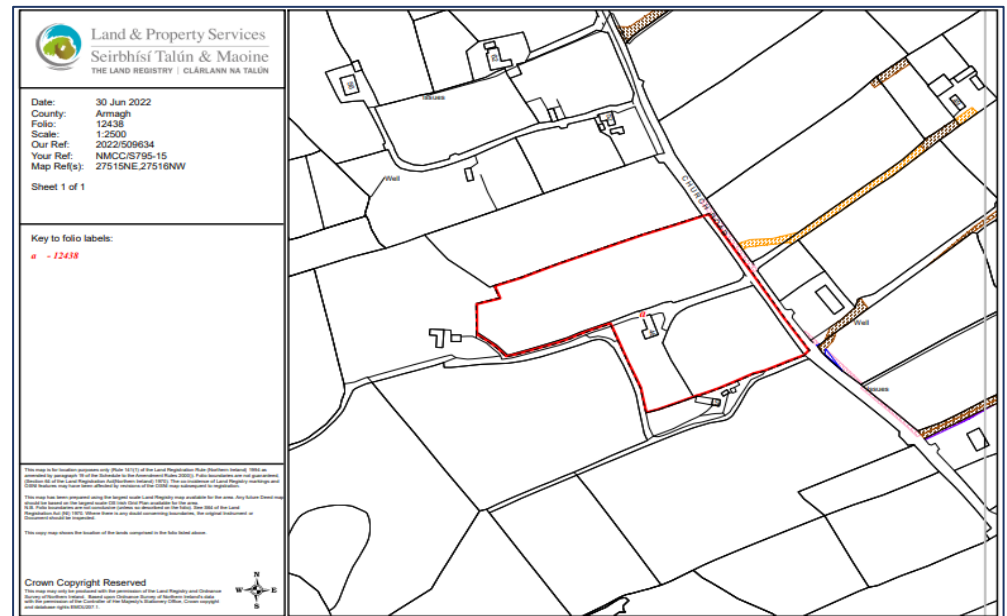

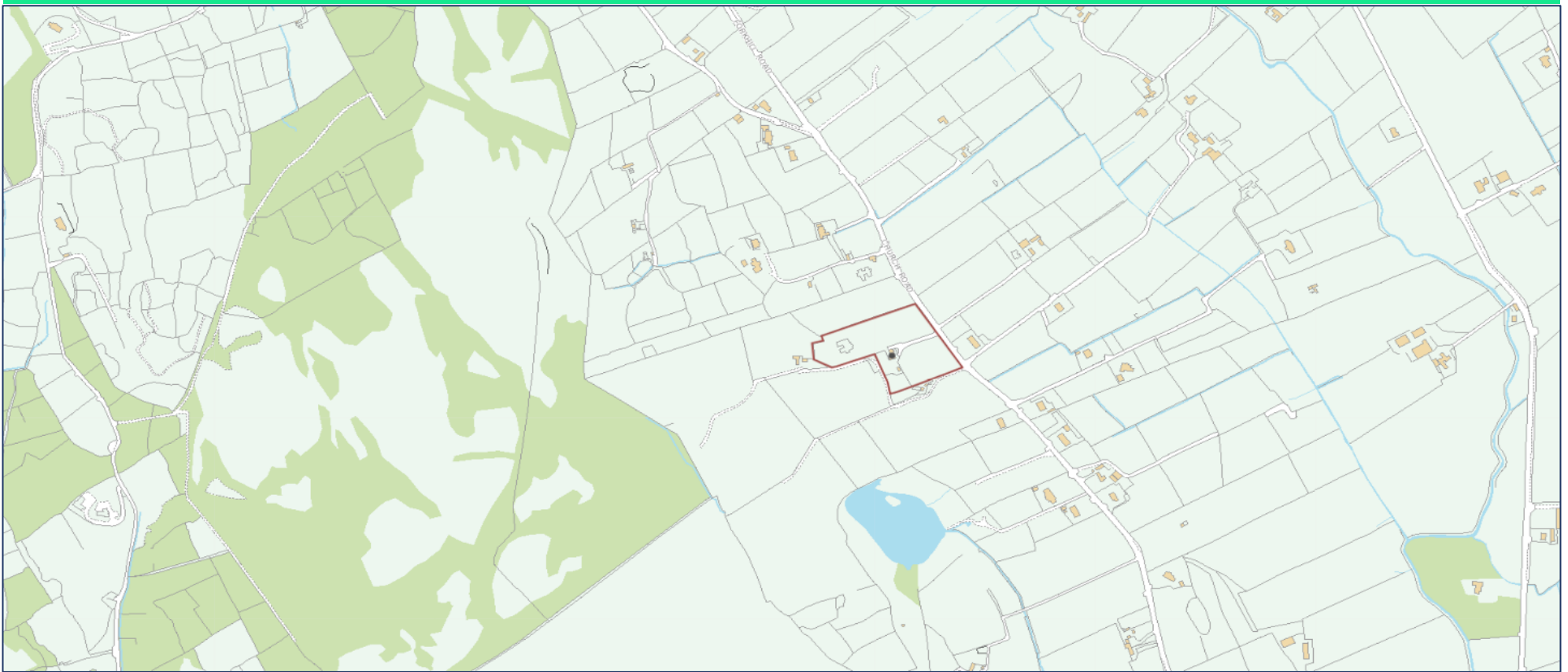
