The unit is self contained with its own private entrance, kitchen facilities, WC located on the first floor and a private rear garage / store.

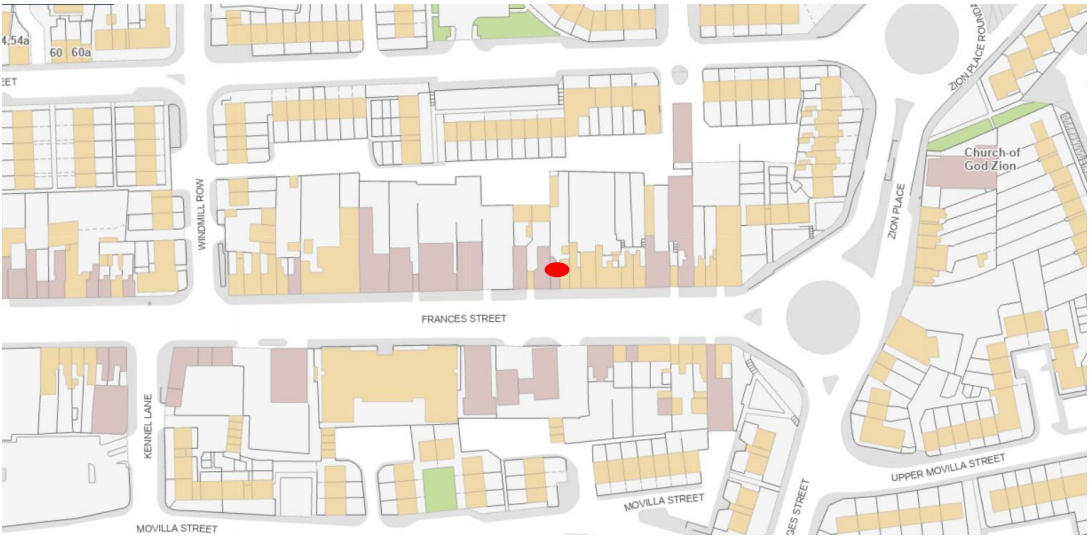

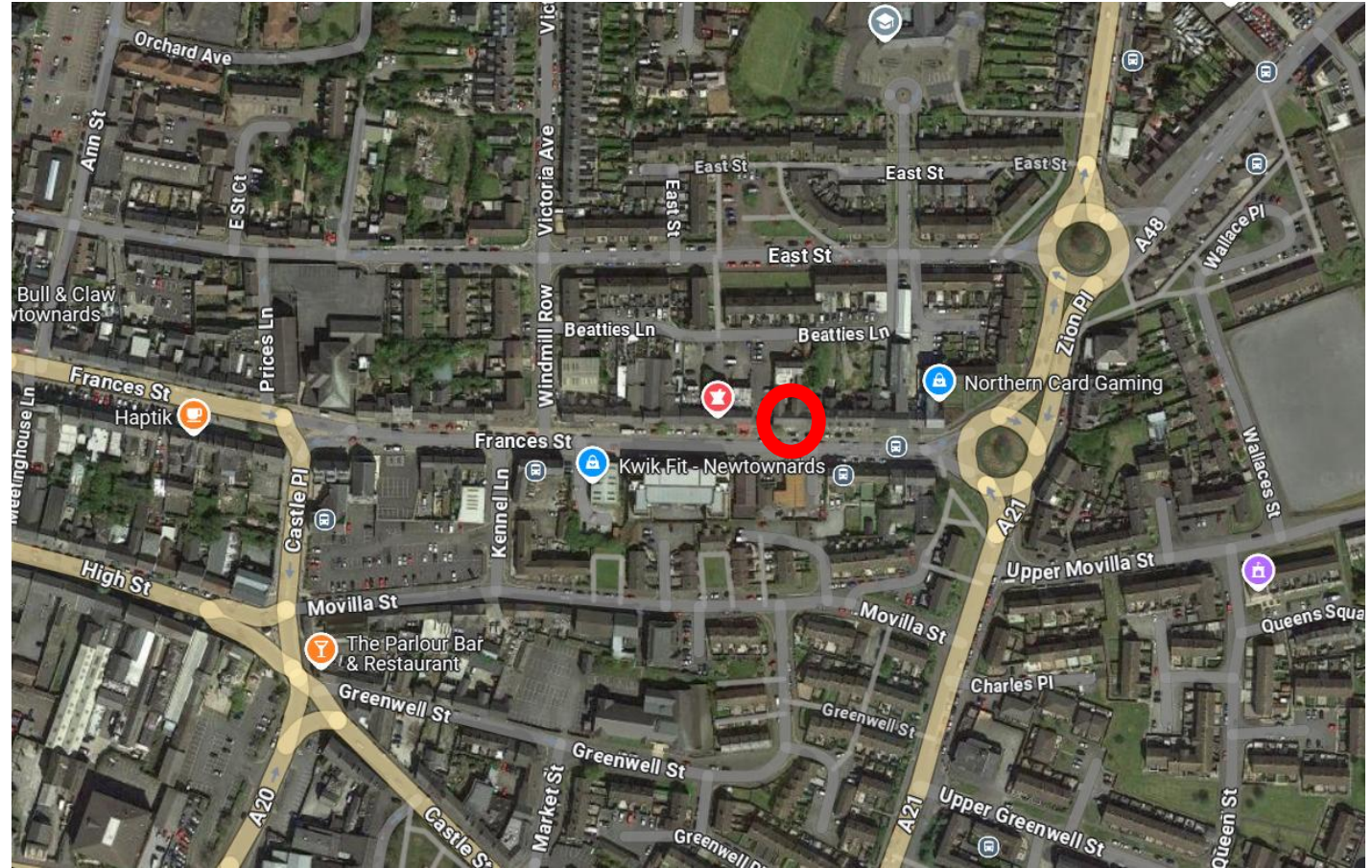
