## Location & Description

The subject property is located in Derry/Londonderry, the second largest city in Northern Ireland benefitting from a strong cross border trade with the Republic of Ireland. The City is well connected via a number of excellent road networks, with access from Belfast via the M2 and M22 Motorways.

The property is situated along the NW side of Rosemount Avenue, at its junction with Rosemount Gardens within a convenient and densely popular residential area which fronts onto Brook Park Leisure Centre. The City Centre can be easily accessed by foot, approximately 10 minutes away.

The subject property comprises of a large four-storey red brick built property. The listed building and former shirt factory was erected in 1904.

We calculate the approximate Net Internal Area to be c.248 sq.m (2,669 sq.ft) and is of a rectangular shape.


