LOCATION / DESCRIPTION

The subject is located on Waterloo Park North, one of North Belfast's premier addresses and just a short walk from the Antrim Road which has a range of retailers, cafes and supermarkets. The property is situated less than 4 miles from Belfast City Centre and benefits from good public transport links.

The subject comprises a detached four bedroom house with separate garage; occupying an elevated position on a prominent corner site. The entire property benefits from impressive views across Belfast.

On the ground floor there is a lounge, dining room, office, snug, kitchen, family bathroom with three piece suite and separate WC. The lounge and dining room both have impressive bay windows and the kitchen has light wooden upper and lower cabinets with white laminate worktops and built-in Bosch appliances.


On the first floor there are four bedrooms; two with ensuite and built in wardrobes. There is also a separate WC and a dressing room / potential fifth bedroom. The largest bedroom is currently utilised as a study and has built-in wooden bookcases with glass panels.

There are PVC double glazed windows throughout and the property has oil fired central heating.

Externally there is a detached single garage and a courtyard garden to the rear of the property. There are also manicured lawns to the front of the property, with mature shrubbery bounding the site.


