Armagh occupies a convenient residential location with the City 13 miles south of Dungannon, 10 miles south west of Portadown and 19 miles north west of Newry. Offering strong transportation links, Armagh City has witnessed good levels of new residential development in recent times as it is within an hours commute of Belfast.




# Site Layout Plan - Proposed
