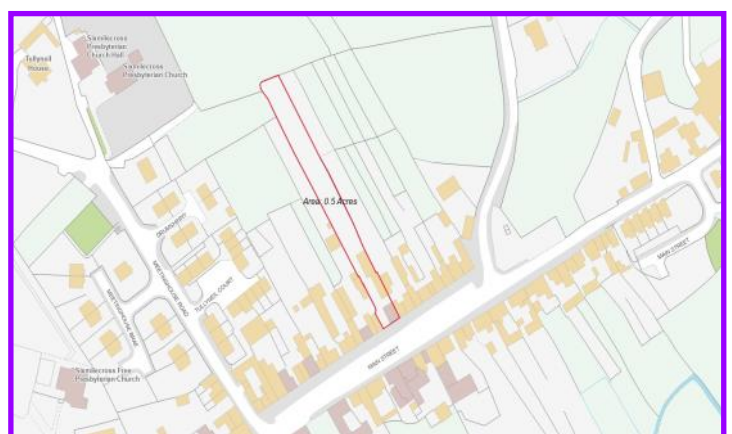


## Indicative Property Boundary Map (For Illustrative Purposes Only)
